The tool and program are for member organizations who want to track and improve their sustainability plans. Organizations using the triple bottom line strategy, Scor3card, engage around three areas of sustainability: people, profit, planet. The tool includes tips to achieve, resource links, reporting capability, and KPI tracking so they can involve their employees, bolster their economic growth, and become better environmental stewards.

The Business to Business Case for Sustainability Series (B2B) brings together businesses to learn from each other about the benefits of sustainability and how they are successfully incorporating the triple bottom line into their business model. This series is held several times a year with both in-person and virtual options, and compliments other programs offered like Scor3card and First Thursday.
